These included cases filed against public authorities for gross negligence in failing to prevent the Easter Sunday bombings of April 2019, as well as the petition challenging the President's unconstitutional exercise of power in pardoning former Sergeant Sunil Ratnayake.

Ramesh was also the Research Assistant to the Commercial Law Reforms Sub-Committee of the Ministry of Justice Sri Lanka which was tasked with advising the Minister of Justice on commercial law reforms and drafting several pieces of legislation including a new Arbitration Act and a Mediation Act.

From 2017 till 2022, Ramesh lectured on company law at the Royal Institute of Colombo.
